Drop Shipping

Drop Shipping is a system that allows website owners to sell product on their website and have it shipped directly from the wholesaler to their customer. This enables you to concentrate on marketing and leave the logistics to us.

FurnitureInFashion is the retail brand name. We are the importer of the products we sell.

Are you a Drop Ship customer ?

The products must be for resale NOT personal use. If you DO NOT wish to warehouse the products or buy the inventory in advance, you are a drop ship customer. If you are willing to warehouse and buy the products, you should visit our wholesale website www.furnitureinfashion.net where you can buy for resale at larger discounts.

How does Drop Shipping work ?

Follow these simple steps and you can be selling online with a few days.

Step 1. Set up a standard customer account at FurnitureInFashion.

Step 2. Complete the Drop Ship application form below and fax, mail or email a signed copy to us. We will confirm receipt and approve the account within 2 business days. We will change your account to a Drop Ship account.

Step 3. Visit FurnitureInFashion to see the discounts we are offering you. Choose the products you want to sell online and copy images and content to put the product on your site.

Step 4. Sell the Products

Step 5. Place the order online at FurnitureInFashion, make sure the shipping address is your customer's address and leave the rest to us. Let us know if you will be sending a receipt by email that you want us to include with the shipment or if you want us to send a blind packing list (no FurnitureInFashion information).

Some important things you should know about drop shipping FurnitureInFashion

1] We try to keep all the products available all the time, but sometimes we do sell out or a product is discontinued. You will need to check the availability online at regular intervals.

2] We provide delivery confirmation on all packages. We ship by the cheapest method possible by private couriers.

3] You will be responsible for customer care and handling any returns.

4] Registration Fee: Yearly registration fee of £299 excluding V.A.T will be charged to cover administration cost.

5] Margins: On each sale we will give you a 5% discount from our retail price of the goods excluding delivery.

6] Auction Sites: You are free to sell a product wherever and however you wish. Please be careful about auctions that could result in you a) losing money and b) selling an item that is out of stock.

7] Coupons and Discounts: We publish occasional coupons and discounts for our retail website. These coupons are not valid for drop ship orders. We are here to support you. When we approve you account we will allocate an account representative. Your account representative will support you and explain any of these issues in more detail.

Rights & Obligations

The Drop Shipper shall ensure that the advertising and the promotion of the products within The Territory conform to all applicable laws and regulations.

The Drop Shipper shall avoid any actions that may bring the FurnitureInFashion product line, and/or FurnitureInFashion into disrepute.

The opening of accounts is at the discretion of The Supplier FurnitureInFashion. FurnitureInFashion reserves the right to suspend or close accounts that violate these Terms & Conditions, misuse our system, or for any other reason without notice.

FurnitureInFashion will not suspend or close accounts unreasonably. Any registration fee paid by The Drop Shipper will be refunded if the account is closed or suspended within twelve months of the commencement of the drop ship agreement. The refund will be prorated on a monthly basis.

FurnitureInFashion reserves the right to change these terms & Conditions without notice.
